The 2023 East Texas Gusher Days Festival is 1½ days, starting Friday, April 14th at 1PM running through 6PM Saturday, April 15th. We invite you to join us! There will be a band/street dance both Friday and Saturday evening, vendors are welcome to keep their booth open during those times. Please note that we are giving booth space and electricity discounts for nonprofits (ID# required to qualify).

Commercial and Arts & Crafts spaces will be mixed together. Corner spaces and center-of-the-street spaces have two sides open to customer traffic. **2022 attendees will be offered first choice of their 2022 space, then beginning March 1 all remaining spaces will be offered on a map to remaining vendors by date of paid application.** Payment can be made by credit card over the phone or in person at the chamber. You will be sent a diagram for the location of your booth prior to Gusher Days, if time permits.

If you have social media accounts for your business (Facebook, Instagram, etc), please send them to the email above and we will let folks know you are coming.

**Failure to comply with the following Rules and Regulations may result in termination of your space.**

1. Spaces are 10' x 10'. No guy wires should extend on sidewalks or other spaces.
2. Electrical fee is per receptacle.
3. **No vendor golf carts or other vehicles allowed in the vendor area during sales hours or the street dances.**
4. Texas Law requires that you collect state sales tax.
5. The East Texas Gusher Days Directors reserve the right to refuse a space to anyone.
